Resident of _____ CNIC No. _____ a student of Pharm-D, at the Mohi-Ud-Din Islamic Institute of Pharmaceutical Sciences Mirpur, AJK, do hereby solemnly declare that:

1. I shall abide by the University/MIIPS rules and regulations as are prevalent and as notified from time to time.
2. I shall have no objection if the authorities take disciplinary action against me in case of default on my part.
3. I shall have no right to the refund of fee in case I discontinue my studies during course of my academic career at the MIIPS.
4. I shall not quit MIIPS against the rules and regulations of the University/Institute.
5. I shall not use the cell phone during study hours and hospital activities.
6. I shall be responsible to pay for any willful damage caused to the University/Institute property due to my negligence / inappropriate use.
7. I shall not become part of, associate myself with or participate in any political or other organization, union, forum, and association or group activities at any level.
8. I shall not keep or facilitate possession of ammunition, knife and narcotics and contraband which I understand is a cognizable offence.
9. I shall strictly abide by the instructions regarding my movement outside the hostel and campus.
10. I shall abide by and follow instructions, rules and regulation issued by the University/Institute authorities.
11. I will pay fees and all other dues regularly by stipulated dates.
12. At any time, during the period of study, if it is found that any information provided by me was incorrect or any of the documents produced at the time of admission was false or fake, which would have rendered me ineligible for admission under the rules then my name shall, subject to any other remedy which the authorities may like to seek, be immediately struck off from the MIIPS rolls. I shall not be entitled to subject or seek any remedy for the aforesaid decision of the authorities regarding my removal from the Institute rolls and that the decision of the authorities shall be final.
13. In case my name is struck off the Institute rolls, under clause 12, I will not be entitled to claim refund of fees and dues paid by me to the University for the academic year.
14. I undertake to attend to attend minimum of prescribed percentage of lectures, seminars, clinics and practicals of each academic year, through my academic career, failing which my name may not be sent the University for the professional Examination.
15. I can be stopped by the Institute authorities from appearing in the University examination on account of my unsatisfactory academic performance during the respective academic year or my failure to pass the send-up test conducted by the Institute.
16. I realize that I will not be promoted to the next higher class, until I have cleared all the subjects of the previous class of the Pharm-D program.
17. In case I am found to be guilty/involved in any of the undesirable activities during my stay in the MIIPS, the institute authorities can rusticate me temporarily or expel me permanently from the Institute and that I shall neither have any claim, nor will I go to any court of law against the decision of the authorities.

18. In case a disciplinary action is taken against me by the authorities, I shall not try to create a law and order situation or instigate the Institute students against the action taken by the authorities concerned.
19. I fully understand that in case there is any dispute between me on the one hand and the authorities on the other, regarding my involvement in a disciplinary or a political matter or regarding the imposition of any penalty or damages on me, the matter shall be referred to the Principal / Deans / Vice Chancellor as the sole arbitrator and his decision shall be final not be called in question in any court of law and shall be binding on me.
20. I will abide by the decision of the authorities in case I am found guilty of indiscipline, defamation, disrespect to the teachers, officers or staff of the MIIPS or having committed other activities.
21. I understand that my failure to observe the above mentioned undertaking would render me liable to cancellation of my admission/expulsion from the Institute and that the decision of the University authorities in this regard shall be final and shall not be challengeable in any court of law.
